On Friday 20th August at 1000hrs I viewed all seven (7) MP4 files at Addington Police Station on my own. The footage appears to me to have been recorded on a mobile phone. The person recording is not seen and not heard talking. Although all of the video footage seems to be recorded in a landscape format instead of a portrait, which would be easier to watch, the clips can all be viewed and are mostly of a clear nature. The date and times are not recorded on the footage and therefore I have had to guess at what times of day these were filmed. Below is a short account of what each of the clips show and what can be heard. Also listed is how long each clip lasts:

Video 1 - 1m16s - Unsure when this was filmed as the screen only shows a half red and half black screen. No persons or property can be seen. Voices are heard talking in the background but not particularly loud.

Video 2 - 33secs - Film shows empty rear garden of Seafood Den but not the restaurant itself. Looks to be late at night. Sounds of loud voices can be heard in the background and these appear to be coming from rear gardens in direction of numbers 19 or further away. Looking out from Seafood Den this would be over the right hand fence.

Video 3 - 32secs - Film shows rear garden of Seafood Den however for a split second the camera pans round to the restaurant and it appears people are leaving through the front door onto Portland Road. The video is late at night. A large table is littered with empty bottles of what appear to be lager bottles. These are perhaps the remnants of a gathering or small party. Noise can be heard coming from the right hand fence again and this consists of loud voices from a number of people. Unable to decipher which premises though.

Video 4 - 42secs - Film shows empty garden of Seafood Den but not the restaurant itself. Appears to be either early morning at sunrise or early evening at sunset. Again, loud voices can be heard from an unknown venue and its possibly a lot of people.

Video 5 – 40secs – Film shows mainly the right hand side fence of an empty Seafood Den garden but not the restaurant itself. Loud music can be heard from the other side of the fence but unsure as to which premises it is coming from specifically.

Video 6 - 1m08s - Film appears to have been taken late at night (very dark). It shows the empty rear garden of Seafood Den. Faint music can be heard but this appears to be coming from the other side of the fence on the left this time, towards number 15 Portland Road or the flats on Albert Road. Also, there are the sounds of loud voices - perhaps that of a party/gathering. Unsure which premises exactly.

Video 7 - 2m03s - Film shows the empty garden of Seafood Den but not the restaurant itself. Possibly filmed in the early evening due to the light. Very loud voices, some shouting heard from other side of the right side fence again. Sounds like a large gathering. Unsure which premises exactly.

All of these clips will now be saved to a DVD.
