



Dear Members of the Licensing Committee,

I write on behalf of the Metropolitan Police Service to object to the grant of a premises license to 100 Beulah Road, Thornton Heath.

We have concerns that the applicant, Mr Sajeevan VELAUTHAMPILLAI, will be unable to operate the premises in a way that upholds the objectives of the Licensing Act 2003, so we request the application is rejected outright rather than being granted with conditions.

The reasons for this is as follows:

#### Public Nuisance:

Beulah Road, Thornton Heath, has a persistent problem of street drinkers who often hang around outside the off licenses there. They drink large quantities of high strength cider throughout the day and cause problems and general friction with members of the public.

Within 200 metres of 100 Beulah Road there are five off licenses already. More information about the impact of off licenses in this area are evidenced by local PCSO Deborah STOREY in an accompanying statement.

Granting a premises license to permitting sales of alcohol at 100 Beulah Road will move anti-social and problematic groups to outside the shop. This will risk potential clashes between parents/ carers and children, and the street drinkers, whilst currently they are separated by a safe distance to the nearest off license.

We suspect that the applicant will operate 100 Beulah Road in a way very similar to his other retail premises and wish to note a link between the applicant's other licensed premises and local street drinking populations.

All the applicants other premises we are aware of (906 London Road and 834 London Road, Thornton Heath; 6A High Street, South Norwood; 87 Norwood Road, Brixton) sell single cans of

cheap high strength alcohol that appeals to street drinkers. (see images at the end of this submission).

Generally, more family orientated businesses where children visit the premises (supermarkets for example) will not stock these products so as not to attract anti-social street drinkers into and around their shops.

Problem street drinking in South Norwood has attracted complaints from the public, so the local police team visited and wrote to all off licenses in South Norwood High Street asking each business to voluntarily cease selling single cans of beer and cider above 6% ABV.

However, whilst most premises were supportive of this and no longer sell high strength cans, 6A High Street refused to support the measure. Residents have complained in particular about that shop's sales of 'K cider' – empty cans of which have littered the streets of South Norwood. The police have noticed intoxicated people and street drinkers regularly visit the shop to purchase high strength alcoholic beer and cider.


#### Protection of Children:

100 Beulah Road is located next door to Beulah Junior School and Beulah Infant and Nursery School. It is also opposite a local scout group. In terms of immediate proximity to children this premises will be the closest of all premises on Beulah Road.

The applicant is putting forward a condition common to off licenses that they will operate a 'Challenge 25' scheme, however we have doubts about the applicant is other premises willingness or ability to refuse anyone, therefore it will likely be ignored at 100 Beulah Road too.

On Monday 22<sup>nd</sup> May 2023 when the police visited 6A High Street, South Norwood the single member of staff was not aware what a refusals log was or where it would be if it was on the premises. It is a condition of the license there. They called someone connected to the premises in our presence on the phone asking where it was to show us, but it still could not be found despite searching around the counter for it. This breach of the license requirement has been highlighted to the DPS.

The same day at 834 London Road, Thornton Heath, the single staff member on duty found the refusals log after several minutes frenzied searching around the counter. Upon locating it and brushing the dust off it, it was opened for inspection. The last entry made was over a month ago. The refusals log appears to have been acquired following a previous visit by the police specifically to remind them to record entries in the log as the premises license required to demonstrate that people are actually being refused age restricted goods on the premises. (see image below).

#### Prevention of Crime and Disorder:

Pursuant to section 136 of the Licensing Act 2003 it is an offence to carry on or attempt to carry on a licensable activity on or from any premises other than under and in accordance with an authorisation.

One of the applicant's premises at 906 London Road was recently found operating beyond it's licensed hours in March 2023 by the police. At 0220 hours on Sunday 12th March 2023 the police responded to a call about a suspect threatening the staff after stealing some cans of beer whilst they were open. The licensed hours of the premises terminate at 0100 hours.

Engagement and enforcement action was taken in this case in accordance with Section 182 guidance.

Beyond this there is little reported crime at the applicants premises in common with most other similar retailers. The example above is raised as a more general point that the police have yet to come across the applicant, Mr VELAUTHAMPILLAI actually working inside one of his premises on the occasions of our visits, and usually find a single member of staff working on their own behind the counter. Lack of onsite supervision of these staff members is likely a reason for generally poor compliance at individual premises with their premises licenses compared to other similar but unrelated off licenses around the borough.

The applicant, Mr Sajeevan VELAUTHAMPILLAI, is the designated premises supervisor (DPS) for all the licensed premises mentioned in this document whose activities have caused some concern for us. We believe it would currently send the wrong message if he was granted more licensing

authority when we have some concerns over his ability to manage his existing authorities and may have to take enforcement action about them if improvements are not forthcoming.

#### Re: High Strength Alcohol and related Anti-Social behaviour

Dear Premises Licence Holder,

Police are seeing an increase in anti-social behaviour in South Norwood High Street, this is being directly linked to individuals who are drinking high strength alcohol from off licences within South Norwood High Street. We would consider any beer or cider over 6% ABV to be high strength.

In recent years, we have taken the decision to add an ABV limit to all new licence off licence and supermarket applications, as we find these premises then report less crime and do not have a negative impact on the local community.

We have also received information that alcohol dependant customers, are being provided with alcohol on a have now pay later basis, when they are unable to pay. This is unacceptable and must stop immediately.

Due the impact, this increased anti-social behaviour is having on the local community. We feel it is now time to take action and are therefore in the first instance asking that you all voluntarily introduce a 6% ABV limit on beers and cider.

As you are aware one of the licensing objectives is the Prevention of crime and disorder, if we find that your premises continues to sell these products and we can prove a direct link to your premises, we will review the licence asking the licensing committee to add an ABV limit.

As you can see Croydon Council have already stated in their Statement of Licensing Policy, that an ABV limit is an option for dealing with anti-social behaviour and crime.

**5.2.8** - Drugs, violence, anti-social behaviour and theft of customers property are examples of crime and disorder issues which may be addressed by the following examples of recommended management practice being included in operating schedules, having due regard to the type of premises and/or activities –

Other schemes including only purchasing alcohol from authorised wholesalers, not selling certain alcohol types/strengths (e.g. high strength beers/ciders or single cans above 6% ABV). Restricting sales on certain alcohol types (e.g. miniature spirits), allowing a 'track and trace' identifier, on products so Police/Trading Standards can identify which off-licence seized alcohol is from, signing up to local responsible retailer schemes

We look forward to using this opportunity as a means of improving South Norwood High Street.

On Monday 13<sup>th</sup> March 2023 I attended G1 Food and Wine, 834 London Road, Thornton Heath, CR7 7PA with my colleagues PC Edwin Sear and PC Chris Woods. The purpose of our visit was to carry out a compliance inspection of your premises licence 05/02959/LIPREM. The licence was issued to you by Croydon Council on 19<sup>th</sup> August 2005 and contains 4 conditions under Annex 2.

Whilst at the premises we spoke with you on the phone and discussed the conditions below, training records and refusal register were not on site. And the member of staff working was not able to operate the CCTV. Can I remind you of the conditions on your premises licence-

- 1. A cctv (closed circuit television system) is installed at the premises and operated at all times licensable activities are taking place. Recordings shall be kept for a minimum of 30 days and made available to Police and authorised Council officers, in useable form, on request.
- 2. A refusals/incident book is kept at the premises to record all occasions when the sale of alcohol is refused and the reason why. The refusals book shall be available for inspection by Police and authorised Council officers on request.

3. All staff employed at the premises are trained with regard to the Law relating to the sale of alcohol. Refresher training to be provided and records of that training to be made available to Police and Council officers on request.

Can you please email me copies of your staff training records and refusals book, and a screen shot of your CCTV from 30 days ago to show it is recording for the correct amount of time.

For the safety of your staff and members of the public can you please ensure you always have someone on the premises who can operate the CCTV.

I must advise you that to conduct a sale of alcohol in breach of premises licence conditions is an offence under section 136 of The Licensing Act 2003. You should therefore cease conducting sales of alcohol until you are compliant with all the conditions on your premises licence.

The Metropolitan Police as a Responsible Authority under the Licensing Act 2003 reserves the right to initiate a Review of your Premises License and take enforcement action with reference to the commission of offences under the 'Act'

If I can be of any further assistance to either of you please let me know.

This statement is in relation to a new premises licence application for 100 BEULAH ROAD. THORNTON HEATH. My statement must relate to at least one of the licensing objectives which are:-

The prevention of crime and disorder

Public safety

The prevention of public nuisance

The protection of children from harm.

BEULAH ROAD is not covered by a PSPO and has NO Council CCTV covering the location.

100 BEULAH ROAD is a convenient store situated directly next to BEULAH JUNIOR SCHOOL. This store has already come to the notice of the THORNTON HEATH SNT as we were asked to visit the store due to them having issues with secondary school children shoplifting. When asked to download images so officers could see the school badge logo they were unable to do this due to a technical issue. On the occasions we visited the store there was one female assistant present.

BEULAH ROAD, THORNTON HEATH is a mixture of residential properties and commercial. The road is split in half by PARCHMORE ROAD. The east side is residential and also has a garage and part of the PARCHMORE ROAD GP SURGERY.

The west side starts from number 54 up to 128 on one side of the road and from 51 up to 145 on the other side of the road. The commercial premises are between 54 and 100 and 51 to 77. A short section of the east side, approximately 150m is where the anti-social behaviour occurs. The anti-social behaviour poses a safety concern, particularly for women and girls. The ASB is affecting the quality of life of the local residents and others using or moving through the location.

The gathering of groups of males results in unreasonable noise (individuals with sound systems and from vehicle sound systems) and harassment, the majority of which is misogynistic, verbal and aimed at women. This information was collated using STREET Witness Signature: .....

Continuation of Statement of:

SAFE an online portal that allows individuals to report locations where they do not feel safe. The consumption of alcohol is prevalent and drug use is suspected. The males are consuming alcohol bought from the local shops. Shop keepers feel intimidated into selling the alcohol to them. The males use vehicles that park on the pavement to place the drinks on and as a shield to gather behind.

Conduct is persistent, evidenced through, calls to Police from residents, anonymous feedback from individuals and as directly witnessed by Safer Neighbourhood officers. There are two distinctive groups. The main group are older males aged from 30+ the second group are males between the ages of 15-18. The males also stand in recessed doorways.

This behaviour occurs all year round but is most prevalent in the summer months where the groups will be noticeably larger.

These groups predominately gather outside of premises that sell alcohol.

The older group appear to gather for social reasons. Some do not reside locally and use cars to travel to the location. The younger group are more likely to be all local and all boys.

The location has poor lighting and over hanging trees and a high volume of fast food outlets. There is a lack of parking enforcement with cars parking on the pavement, on double yellow lines and zig zags. Litter is a constant, especially empty beer cans and bottles.

Last summer the Safer Neighbourhood Team and Croydon Council were sent emails and mobile phone footage nearly every day by aggrieved residents.

Recently THORNTON HEATH SNT had two AIRSPACES running at the same time, one for each side of the road.

In recent years there have been a number of serious incidents as documented below.

CAD 219/21SEP22 Section 18 at a residential address in BEULAH ROAD – knives, a pistol and fake money found.

CAD 3897/08JAN22 - Stabbing

28/10/2020 a Section 23 MDA warrant was executed at a commercial address. Drugs and firearms found at the location. On 05/03/2023 the location was holding an unlicensed event and was subsequently warned by Croydon Council.

15/06/2019 a section 23 MDA warrant was executed at a commercial address.


