1. Introduction

1.1 Purpose of Equality Analysis

The council has an important role in creating a fair society through the services we provide, the people we employ and the money we spend. Equality is integral to everything the council does. We are committed to making Croydon a stronger, fairer borough where no community or individual is held back.

2.1 Purpose of proposed change (see 1.1 above for examples of proposed changes)

Croydon Council is currently undergoing a re procurement exercise for borough-wide provision of council provided bus shelters and associated advertising via a new contract following the termination of the Valo Smart City contract. The new contract will provide bus shelters and include digital and non digital advertising up to 115 locations within Croydon. The object of this procurement exercise is to provide bus shelters for the residents of Croydon (where the provision is the responsibility of Croydon Council) and provide a stable income stream to the council.

The successful bidder will own, install, finance, operate and maintain all 115 new bus shelters, for the duration of the contract. We would expect the 10-year concession term to start when a minimum of 80 new bus shelters are installed and commissioned. We expect to have first option to install additional new bus shelters and advertising panels during the contract period.

The successful bidder will provide, install and maintain all of Croydon's 115 bus shelters at locations across the borough.

The assessment below is based upon work undertaken previously for the failed Valo contract.

Key considerations in the design of the bus shelters and street advertising furniture

- Accessibility and mobility
- Visual impact
- Crime, safety and anti-social behaviour and data
- Public realm and street decluttering
- TFL and TFL trams
- Digital & non digital advertising screens

It is important to note that the majority of bus shelters within the borough are not provided via this contract but are provided by TfL and other Bus Service Operators.

The installations may have a temporary adverse effect on protected groups during the period of works but this will be easily mitigated against using the actions outlined section 5 of this document with little or no residual impact. The benefits to the council and community are long lasting and therefore outweigh the temporary negative aspects identified leaving a positive impact on the whole council and visitors to the borough.
